This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this the 6th day of January Two Thousand Twenty (06/01/2020)





D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest;.


E) Krishna Industry the Second Party is engaged in leading business in minerals processing.


NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in

CLAUSE 2 SCOPE OF THE MOU





2.3 Industrial Training & Visits: Industry and Institution interaction will give an insight into the latest developments / requirements of the industries the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.


- 2.6 Guest Lectures: Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.

- 2.9 There is no financial commitment on the part of the Deshabandhu Mahavidyalaya, Chittaranjan, and the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately.


CLAUSE 3 INTELLECTUAL PROPERTY

CLAUSE 4 VALIDITY

- 4.1 This Agreement shall be initially valid for a period of 03 years commencing from the date of the agreement that is 6th day of January Two Thousand Twenty (06/01/2020). The term may be extend for further period by mutual consent in writing by the parties, during which period Krishna Industry, the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of Krishna Industry, the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- 4.2 The Parties hereto have set & subscribed their respective hands & seal on the day, month & year herein above mentioned.



