


MEMORANDUM OF UNDERSTANDING (MoU) BY AND BETWEEN DESHABANDHU MAHAVIDYALAYA AND

and

KABITA MEMORIAL FOUNDATION, GROUND FLOOR, ASHTHA BUILDING, WEST APCAR GARDEN, ASANSOL 713304 represented by its Secretary, Sri Jayanta Dhibar, hereinafter is referred to as the SECOND PARTY OF THE OTHER PART.



And whereas both the parties named above agreed to abide by the terms and conditions detailed below under which the College and the N.G.O. will work together in the following sections

ARTICLE 1: OBJECT

On the basis of equality and reciprocity and mutual benefit, the PARTIES agree to implement programs through mutual cooperation which includes but not limited to:

1) Organize Seminars, Awareness Programmes about 'Green Earth', Recycling of waste materials, E-waste management etc.

2) Participation of College students, ECO-club members, N.S.S. volunteers of the College, accompanied by faculty members in the welfare programmes organised by the N.G.O

3) Collaboration of events in local schools, adopted village by the College and market areas.

4) Collection of E-waste from office, schools, households jointly

5) Campaigning for proper E-waste Management jointly

ARTICLE 2: COORDINATION

Each PARTY shall designate a member to serve as the program coordinator on behalf of the principal of the College and Secretary of the NGO. A Coordination Committee, will periodically review and identify ways to strengthen cooperation between both the PARTIES.

ARTICLE 3: CONFIDENTIAL INFORMATION

Each PARTY will retain and respect individual confidentiality, including those pertaining to the collaborative activities of both the PARTIES.

ARTICLE 4: VALIDITY

Initially, the MoU shall remain in force for a period of two years commencing from the effective date; which may be extended beyond the term of two years by written agreement signed by both the PARTIES.

ARTICLE 5: TERMINATION

Each PARTY may terminate the MoU by giving written notice of Three months in advance to the other PARTY.

ARTICLE 6: LEGAL EFFECT

Nothing in this MoU shall be construed as creating any legal relationship between the institute and organizations.. This MoU is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 7: DISPUTE RESOLUTION

In case of a dispute relating to any aspect of mutual cooperation, Principal and Secretary of both PARTIES will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

ARTICLE 8: AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the Principal and Secretary of both PARTIES.

Both the PARTIES welcome the execution of this Memorandum for cooperation and jointly agree to the provisions set out as above.
